### **Website images**

The UTC operates the following policy on its website regarding the use of photographs, to ensure the privacy and safety of pupils at the UTC:

- Where pupils are named, only their first names are given;
- Where a pupil is named, no photograph of that pupil is displayed;
- Where a photograph is used which shows a pupil, no name is displayed.

By observing these points, the UTC ensures that visitors to the website cannot link images of pupils to names of pupils. When choosing photographs for the website, the school is mindful of the way pupils may appear in them, and will not include images which are in any way inappropriate, such as close-up portrait shots of individual pupils.

The UTC follows a policy of seeking parents' permission before using images which show pupils on the website. This is done via our policy of regularly sending parents a contact update form on the reverse of which is a permission request for short visits and use of photographs.

**Our aim is to celebrate achievement and enjoyment, if we have published any image which causes concern to a parent or child please inform us and we will remove the image without debate.**

No other private information about pupils is ever published on the website such as surnames or contact details.

## **Website Privacy Policy**

We are committed to safeguarding the privacy of our website visitors; this policy sets out how we will treat your personal information.

### What information do we collect?

We may collect, store and use the following kinds of personal data:

- Information about your visits to and use of this website;
